

# SCS Jamaica: Local Partner Development

## Overview

The Local Partner Development (LPD) project (2017 – 2023, \$15 million) is funded by USAID to advance youth crime and violence prevention while increasing collaboration between government, business, academia and civil society. The project was realigned to focus specifically on youth crime and violence prevention in FY 2020, with the new direction beginning October 1, 2019. LPD will enhance the knowledge, skills and abilities of Jamaican civil society to design and implement evidence-based secondary and tertiary prevention programs while ensuring collaboration and coordination with key public and private sector partners.

## Jamaican Context

Persistently high levels of youth crime and violence threaten Jamaica's economic and social progress. A 2017 study by the Inter-American Development Bank estimates that Jamaica lost almost 4% of its 2014 GDP to crime-related costs. Jamaica's vibrant and active civil society could respond more effectively to Jamaica's crime and violence epidemic but needs to enhance capacities and structures to do so.

## Major Program Components

**Strengthening the capacity** of targeted local Jamaican entities through:

- *Stepping Stone to Success*, an organizational development program for grassroots CSOs. Selected CSOs participate in monthly workshops, mentorships, and peer learning groups, and gain access to grant opportunities.
- *Pathways to Sustainability*, an institutional strengthening program which seeks to increase the capacity of advanced CSOs working to reduce or prevent youth crime and violence through grants and capacity development interventions.

**Supporting social enterprises** through a business incubator model which:

- Implements and funds customized business and organizational performance development plans that are targeted to each SE's specific needs.

**Improving the enabling environment** for CSOs and SEs through:

- Facilitating multi-sector dialogues to advance participatory analyses of legal barriers to CSO and SE legal registration and operations.
- Training both CSOs and public sector partners on international standards related to priority legal issues.

**Promoting intentional collaboration** across civil society, government, and the private sector by:

- Using the SCALE+ systems-thinking approach and awarding 10 Collaboration Grants to support collaborative action to address youth crime and violence.

## Achievements

*(All achievements below relate to the original scope of the LPD project)*

- **Strengthened the organizational capacity and performance of 60 CSOs and SEs** enrolled in LPD's tailored programs, 70% of which are located in towns and rural areas across Jamaica, which are traditionally underserved in comparison to Jamaica's cities
- **Enhanced the organizational management and advocacy skills of more than 130 Jamaican CSOs and SEs**
- **Increased revenue for two SEs** in LPD's business incubator by more than three times the amount received over a similar period in 2017
- At a SCALE+ event in December 2018, **more than 80 civil society and government representatives generated and endorsed five areas of emphases for collaborative action through still active work-groups to address youth crime and violence** in the volatile and vulnerable parish of Clarendon
- **Engaged 56 stakeholders across civil society, government, and academia** in the process of regulatory reform for the CSO and SE sectors
- **Developed videos** depicting Organizational Performance Index concepts through innovative dramas that allow CSOs and SEs to more easily conduct self-assessments
